2001 Regional Conference in Boston Partnerships: Advancing Teaching and Learning

A Bostonian welcome was given to Delta Kappa Gamma members as they arrived at the Sheraton Boston Hotel and Towers.

The conference theme, "Partnerships: Advancing Teaching and Learning," was carried out throughout the convention with opportunities to attend workshops, tours, and other activities.

The Northeast Conference began with the presentation of the flags to kick off Massachusetts Night. The Mayor of Boston extended his greetings and best wishes for a successful convention. It was gratifying to hear how supportive he is of teachers and education. Young and old entertained with a musical extravaganza. Step dancers, a tap dancer, and male and female choral groups delighted all present.

Dr. Theresa Fechek, retiring Executive Coordinator, was honored with a reception hosted by the Massachusetts State Organization. Dr. Fechek is presently working on gathering data to update the history of the Society.

Evelyn Barron, 1998-2000 International President, has assumed the duties of Executive Coordinator.

Donna Brown, Northeast Regional Director, welcomed all to the 72nd year of Delta Kappa Gamma at the Thursday morning meeting. Gracious greetings came from the Sheraton Hotel. Mary Grace McAffrey commented that the hotel staff had been inspired by all our members and our infectious smiling.

Roll call was made with 638 members in attendance. Pennsylvania had 37 members present.

The keynote speaker, Anne Marie Carlson, Member-at-Large, stepping in for Olara Otunna of the United Nations, challenged us to be more aware of the conditions children are exposed to in fifty countries. We viewed a video, "Children in the Crossfire," which told of the atrocities of war visited upon children. "Words to deeds to action" was the message.

International President Carol Mueller related that it was time for our Society to take "words to action" and make strategic planning more proactive.

On Friday morning nearly 300 members attended the U. S. Forum.

Proposals were presented to establish an advocate to represent Delta Kappa Gamma in the nation's capitol. After discussion, Option Application for Foundation-received the overwhelming majority of votes at the Northeast Regional Conference. Votes from the other regional conferences will need to be tallied before the final outcome will be announced. There are still a lot of finer details that need to be worked out. We will be hearing more about this in the near future as to exactly how this will all fit together. Members were encouraged to take part in the National Legislative Seminar in Washington, D. C., in March 2002.

Alpha Alpha State Officers and Committee Chairmen Meet

On August 11 and 12, 2001, the newly elected state officers and newly appointed committee chairmen met at the Best Western Country Cupboard in Lewisburg. After dinner on Friday, the officers held an evening meeting. President Louise Garverick presented her goals for the biennium: teamwork among officers and members, better communication, membership increase, recognition as an Act 48 provider, recognition of educational endeavors across the state, legislative awareness, and emphasis on programs and projects. The other officers who heard the president express her goals were First Vice-President Carol Ulrich, Second Vice-President Lyn Schmid, Recording Secretary Sue Stamm, Treasurer Linda Fisher, Parliamentarian Suzanne Long, Immediate Past President Polly Delaney, Leadership Development Chairman Terri Stetler, and Rules Committee Chairman Rebecca Place.

Other pertinent business conducted during the evening was an explanation by Terri Stetler about the new structure for the Fall Area Meetings. This year there are three area meetings with a variety of workshops carrying Act 48 credit. Two fall area meetings will be planned next year to train all incoming chapter officers and committee chairmen. These working society meetings will be continued in even-numbered years. Beginning in 2003 and continuing in odd-numbered years, several chapters will be clustered together, and the meetings will address problems and concerns.

Plans for the 2002 State Convention to be held at the Penn State on June 7-9 were also made. President Garverick has asked Dr. Sarah Tambucci, principal from the Pittsburgh area, to be Keynote Speaker. There will be a Gallery Challenge for personal exhibits and a roundtable discussion on the Focus 2000 proposals, along with the familiar activities. The president planned to include in her letter to chapter presidents the proposal form for workshop presentations. (The form also appears on page 19 of this Keystonian.) There will be 24 chapters celebrating birthdays at the Birthday Luncheon. (See page 14.)

During the first hour on Saturday morning, committee chairmen had the opportunity to pass materials and/or information on to the newly appointed women. Then the whole group convened, and President Garverick restated her goals for her biennium. The new committee chairmen were introduced and had the opportunity to make comments.

The resignation of Nancy E. James as editor of *The Keystonian* was accepted with regret and thanks. Alpha Alpha State is now soliciting applications for that position.

Polly Delaney, Nominations Chairman, is looking for women who would be willing to be nominated for International participation. She reminded those present that next year chapters will be requested to furnish information about new officers and committee chairmen for inclusion in the state directory. Irene Murphy moved to support the nomination of Jean Gray for International President.

Suzanne Long summarized data from the 2001 State Convention evaluations. Although there was only a 37% response, it was the consensus of the group to continue with the evaluations because they provide valuable feedback and help in planning for future conventions.

The Birthday Luncheon celebrating our 72nd was held on Friday. Grace Corrigan, Christa McAuliffe's

mother, was a speaker.

The Educator's Award for 2001 was presented to Carol Maxym and Leslie B. York for their book *Teens in Turmoil: A Path to Change for Parents, Adolescents, and Their Families.* Leslie York accepted the award. The book was available for purchase after the luncheon.

During the luncheon the Emergency Fund collections was made. This fund is used to help members in need if a disaster strikes. The collection totaled \$3,214.48.

At the second General Session on Saturday morning, brief reports on Society business were given. The Educational Foundation reported that over \$2 million was given for educational purposes in the Society. The final registration totals were 670, of which 118 were one-day registrations. This was the first time ever for one-day registrations at a conference like this.

Invitations for conventions and conferences were issued by Little Rock for 2002, Greenbrier for 2003, and Cleveland for 2007.

Saturday evening the Presidents and Founders Banquet was held. Our own Louise Garverick and Polly Delaney represented Pennsylvania. The highlight of the evening was the presentation of the International Achievement Award. Jean Gray, Maryland, was selected. In her remarks earlier in the evening, Jean said, "If the light goes out in the chapter, the organization ceases to exist." Think about this statement as our membership is decreasing. We all need to work to make this light shine brighter.

Pennsylvania was well represented throughout the conference. Many members were timers, presenters, presiders, and recorders for general sessions and

workshops.

The 2001 Northeast Regional Conference was truly a laboratory for teaching and learning. Each of us experienced opportunities for personal and professional growth, with the historic city of Boston as our classroom.

Prominent speakers from organizations actively engaged in environmental and sustainable development issues will present; panels showcasing student and school environmental projects will be featured; and an information fair, sharing complimentary teacher resources, will be included. The registration fee for the day is \$30.

At the start of the 21st century, no issue looms larger than the global environment and its many problems. Increasing pollution, devastating storms, and advancing deserts sound the alarm for the future of our well-being on planet Earth. Increasing world population and the need to fight poverty put further strains on the environment. None of these threats can be confined within one nation or even one continent. None of them will go away any time soon. That is why we need to give our children the best possible education on this complex issue, so that when their time comes, they will be able to act knowledgeably and wisely on behalf of us all.

The United Nations is uniquely equipped to help us to think clearly about all aspects of the environment. In 1992 the UN led the way by focusing on the issue at the UN Conference on Environment and Development in Rio de Janeiro, and soon the UN will hold a 10-year evaluation of this landmark event. This time there is an added dimension: how to fight the battle against poverty through sustainable development that does not increase pollution or desertification. Progress has not been easy, as is shown by the recent controversy over

the Kyoto Protocol on Climate Change.

CTAUN is pleased to make the global environment the focus of its 2002 conference for educators at the United Nations and to make available to all participants the fascinating range of resources the UN has been gathering since Rio to enable teachers to come to grips with this critical subject which is crucial to the survival of us all.



Who Can Be Invited to Active Membership? A Suggested Chapter Discussion

Although the final decision regarding membership is the responsibility of the individual chapter, each chapter must adhere to the Constitution and Standing Rules of The Delta Kappa Gamma Society International in recommending women educators for membership.

The interpretation of the following phrases in both official documents needs to be discussed by each chapter in order to realize that there is great flexibility in searching for and acquiring new members:

"women who are employed in educational work at the time of election" "employed shall mean currently hired by an employer and/or paid a salary or fee for specific educational services"

"have had three or more years of experience as professional educators" "teaching shall be interpreted to include one-to-one as well as group instruction"

A chapter discussion of the above phrases might raise the following questions: Can we invite pre-school and nursery school educators? Central office personnel involved in instruction? Full-time aides who work in the classroom?

Can we invite professional educators who tutor? Or who teach music or art on a one-to-one basis?

Can we invite librarians instructing in public libraries? Religious educators? Businesswomen responsible for employee training?

Can we invite registered nurses involved in patient education programs? Psychologists, social workers, policewomen directly involved with students on a regular basis?

Are there other professional educators that the chapter could invite if the chapter is in agreement and if the educator meets the flexible membership description in the Constitution and Standing Rules?

The answers to the above questions are YES! Any of the women described above could be invited to membership—IF THE CHAPTER AGREES. No decision should make a member in the chapter uncomfortable, nor would it be fair to a new member who was initiated into a chapter in which she would feel she was not welcomed by part of the chapter.

Other questions that a chapter might ask are: What about a president of a PTO?

A regular volunteer in a school? A school photographer? A retired educator?

The answers to these questions are NO. If the women are not professional educators, currently employed in educational work, they are not eligible for active membership in the Society.

The Alpha Alpha State Membership Committee urges your chapter to discuss this membership information as you consider how to bring in new, active members to help you grow and thrive. The discussion could strengthen your chapter!

Deb's House-A Safe Place

from Chi Chapter Newsletter, September 2001

"A safe place for families in crisis," reads the byline for Deb's House. Deb's House is a 24-hour crisis nursery serving Lancaster County children ages birth through 6 years. . . . A parent may call Deb's House to arrange for care of the children during a difficult situation at home. Children remain in the parents' custody during their stay at Deb's House. The family must be willing to work toward long-term stability. Case management services provide individualized guidance and referrals to community support. Counseling assists the family in resolving the current crisis. Parent education and supports are offered.

A first-time event at this year's conference at Penn State was the Great Cookie Challenge. Theta's entry was delicious nut horns, compliments of Judy Karavlan. There wasn't a crumb left on the plate, so we know that they were enjoyed by all. A great big thanks to Judy for her time and wonderful recipe. Here's her recipe for everyone to enjoy!

Judy's Nut Horns

Combine:

2 heaping cups of creamed cottage cheese

1/2 lb. butter

1/2 lb. margarine

1/2 cup sugar

2 tsp. vanilla

Mix in mixer until fine.

Mix in 4 cups of flour by hand. Mixture will be wet. Scoop out approximately ½ cup=1 ball. Wrap each ball in plastic wrap, place in plastic bag, and freeze at least overnight. Recipe makes anywhere from 8 to 12 balls=8 to 12 dozen nut horns.

Roll each ball between wax paper. Roll in a circle approximately the size of a dinner plate and freeze flat on a cookie sheet. Must be frozen before cutting into 12 pieces like a pie.

Put on nut mixture. Roll big parts to small (roll while a little frozen). Place on ungreased cookie sheet, sprinkle with sugar before baking at 375° for 15 minutes or until lightly brown.

Nut mixture:

1 1/2 lb. ground nuts (grind twice)

3 egg whites (slightly beaten by hand)

1 ½ c. sugar (not real wet)

(Judy uses 2 lbs. nuts, 4 egg whites, 2 cups sugar.)

ACHIEVEMENT AWARD GUIDELINES Revised 1998

 Purpose: The purpose of the Alpha Alpha State (Pennsylvania) Achievement Award is to recognize and honor a member who has given distinguished and outstanding service to Alpha Alpha State and has promoted the purposes and the policies of the Delta Kappa Gamma Society International.

2. Criteria for Selection:

A. The nominee must be presently an active member of Alpha Alpha State. (Reserve and honorary members are not eligible for this award.)

B. The nominee must have a minimum of ten years' membership in Alpha Alpha State of the Delta Kappa

Gamma Society International.

C. The nominee must have served in a leadership role in her chapter as president or vice-president and must have contributed to the work of chapter committees.

The nominee must have given distinguished and outstanding service to Alpha Alpha State in two of the

following leadership roles:

 As a consultant or a leader in the conducting of seminars and/or workshops at the state and/or international level.

As general chairman or co-chairman of an activity at a state convention, regional conference, and/or international convention.

As a state, regional, and/or international committee chairman and/or state officer.

E. The nominee must have been endorsed by either her chapter's executive board or another chapter's executive board with the prior approval of the executive board of

the nominee's chapter.

F. Each chapter has the privilege each year of nominating one member of Alpha Alpha State for this honor. It should be emphasized that the award is given for leadership, not merely the discharge of duties.

G. Chapters have the privilege and are encouraged to resubmit names of previous nominees who have not been selected. The State Achievement Award Committee maintains all nominations for five (5) years. Any chapter wishing to resolve in the contract of the contract o wishing to resubmit a name for nomination must complete the add-on nomination sheet in order for that nominee to be considered for the award another year.

H. No member may receive the award a second time. No state officer shall be eligible for the award during her

term of office.

The award is presented on an annual basis. K. The nominee's chapter Membership and Research committee chairmen may be contacted for information to be used in preparation of the nomination form.
