



Criteria for Album of Distinction Candidate

The following criteria have been established to create a consistent recognition for Alpha Alpha State members. Please read each item carefully before completing the Nomination Form.

- ★ Recognition must be for an honor received for community service or high distinction outside The Delta Kappa Gamma Society.
- ★ Recognition will be given on an annual basis during the State Convention. This year's candidates shall have received their honors between May 15, 2004 and April 30, 2005.
- ★ The nominee must be a contributing/participating member in good standing with her chapter (including Active, Reserve, Honorary members).
- ★ A complete nomination form will be filed with the chairman of The Professional Affairs Committee by May 1, 2005 in order to be recognized at the 2005 convention. Nominations for candidates receiving awards after the stated deadline may be submitted for recognition during the following year's convention.
- ★ All Album of Distinction awardees will be honored at the State Convention Friday Night Reception on June 10, 2005. Award winners and their Chapter Presidents are expected to attend.
- * A wallet-sized picture of the nominee must be included with the nomination form.
- * Any member can file a nomination form on behalf of another member except herself.
- ★ All awardees will be notified of their selection by May 15, 2005 in time to register for the Convention without a late charge.

PERSONAL GROWTH AND SERVICES COMMITTEE By Susan Stamm, Chairman

In the last issue of *The Keystonian* this committee shared ideas from Muriel O'Tuel. These ideas were taken from her workshop at International Convention in Minneapolis and from her book, *Footprints on the Heart*. I would like to continue sharing some of her thoughts on love and leaving footprints in this column.

Muriel says that in order to leave lasting footprints, we have to show love - the kind of love that shows action and involvement. You cannot leave footprints unless you move. If you expect to influence people, you have to model the behavior you want to see in them. Act as if you are motivated and enthusiastic. Positive persuasion is the most effective way to motivate people. It works by making others feel important. Persuasive people are those who give others status; who give recognition for the things others do right; who are constantly encouraging others; and who communicate freely and honestly.

Here are a number of ways you can make others feel important:

- Be accepting. Accept people for who and what they are. Advertise your acceptance with a smile.
- ▼ Show approval. Be generous with your praise.
- Show appreciation. Say please and thank you, and treat others as if they were guests in your home.
- Compliment people on things you admire about them but be sure you are sincere.
- Never criticize. Negative criticism is destructive and it's something the receiver never forgets.
- Never argue. When you argue with someone else, you're saying, "You're wrong," and nobody wants to be told that.
- ▼ Listen. When you listen to what others have to say, you'll find out what they value and like.

Making others feel important is the key to happy interactions, and interacting with others is a key to your own happiness. To get along with others, however, you have to get along with yourself. If you don't like yourself, others won't like you. Neither will you like others. To feel good about yourself, you need enthusiasm. When you think positively about yourself and act in a confident manner, you will show enthusiasm. You can provide a solid basis for that confidence by developing the seven qualities of leadership:

- ▼ Integrity. This is the quality that attracts the confidence of others. It embodies the qualities of dependability, uprightness, honesty and loyalty.
- Perseverance. This is the quality that persists in the face of difficulties; that never acknowledges defeat.

- ♥ Faith. Strong leaders believe in the ultimate triumph of right. The writer of Hebrews declares, "Faith gives substance to our hopes and makes us certain of realities we do not see."
- Ability to plan. This involves a knowledge of the facts, judgment as to their relative importance, mastery of the job, skill in organizing to accomplish a purpose, and efficiency in coordinating the work of others without showing off or showing them up.
- Vision. This quality calls for a breadth of viewthe ability to grasp the big picture.
- ▼ Initiative. This is the ability to move ahead without waiting for a shove.
- Courage. True leaders are risk-takers who are willing to take chances on losing because they know they have the spunk to try again.

Your life is full of opportunities to leave footprints on hearts. Start with your own personal growth and develop some of these qualities, and you may be amazed with the results.

STATE COMMITTEE COMMUNICATIONS



LEGISLATIVE

The topics of this Legislative Link article are: Effective Advocacy Tips, Funding 2005/2006, and Retirement Issues.

Effective Advocacy means researching current legislative issues and your Representative's and Senator's position on these issues. Finding a mutual interest with your legislators and their staff members sends the signal that you have done your homework. It may also smooth the way to easy conversation whether you are communicating in person, by letter, email or phone.

I. ADVOCACY TIPS

- A. Website-Visit his/her website. Find out which committees they serve on and what their interests are.
- B. Web Search-Log on to your favorite search engine (yahoo.com, google.com) and type in your legislator's name. Take notes on your findings.
- C. Get Out There-Attend functions where your legislator is visiting: local government events, breakfasts, town meetings.
- D. Send Invitations-Invite them to your school.
- E. Network-Talk to your friends, family, and colleagues. Find out what their thoughts are on the issue.

II. FUNDING 2005/2006

A.ISSUE: FUNDING

ACTION: Advocate for the adequate funding (the process begins in Feb. 2005 for the next fiscal year) of federal education programs. NCLB is underfunded by more than \$9 billion.

B. ISSUE: NCLB ADJUSTMENTS

ACTION: Advocate for NCLB adjustments such as changing the regulations for special education students and English Language Learners. Suggested adjustments would call for measuring progress by comparing individual student achievement and comparing the same student groups from year to year.

C. ISSUE: EARLY CHILDHOOD EDUCATION ACTION: Advocate for the support of state and federal funding for pre-kindergarten and kindergarten programs.

III. RETIREMENT ISSUES

A. ISSUE: CERTIFICATION

ACTION: Support legislative proposal to exempt retirees from Act 48-continuing education requirement.

B. ISSUE: COLAs

ACTION: Promote proposals to provide COLAs to all school retirees; amend the PA Constitution to give authority to the General Assembly to provide COLAs to the spouse of

- deceased retirees and to establish an automatic system of giving COLAs on a yearly basis.
- C . ISSUE: HEALTH INSURANCE ACTION: Support proposals to increase the amount of health insurance premium assistance; expand eligibility for premium assistance to include 15 or more years of service and age 65, and establish equity with retired state employees regarding medical coverage.



An Enrichment Grant Experience LONDON BOUND--LIGHTS! CAMERA! ACTION!

Music and dance through theater can cross cultural boundaries, so when Broadway Across America notified the subscribers of the Pittsburgh Broadway on Broadway Series about the upcoming trip to London, England, our interest in theater was peaked.

Are there noticeable differences in British theater compared to American productions? This was the question which sparked our research via an Alpha Alpha State Travel/Study Enrichment Grant proposal. With this in hand, we were London Bound!

Most of the entire week's itinerary was theater based, including our tour guide, Chris Vincent, who was an established West End singer/musician. He was always willing to answer our questions and provide insider information. When we departed, he was being recalled for the role of one of the theater managers in a production of "Phantom of the Opera."

Our first evening in London we met with a professional Australian dancer, Edwina Cox, who appeared in the production "Anything Goes" at the Theatre Royal Drury Lane which we attended later in the week. Edwina shared with us an interesting contrast between British and American musical theaters regarding a performer's age. To continue as a dancer in musical theater, she would soon have to further her career in America or establish another outlet for her talents, such as teaching in a private studio.

Accessibility to the theaters in London is another noticeable difference. In Broadway, New York, the theaters of Times Square are located within easy walking distance. London's West End theaters are widespread, requiring the use of subways, taxis, or long distance walking. We endured each evening's challenge of fighting crowds and keeping up with Chris' fast-paced maneuvers to be on time for each performance.

Our travels included "Jailhouse Rock" at Piccadilly Theatre, "The Complete History of America, Abridged" performed by the Reduced Shakespeare Company at Criterion Theatre, and "Chitty Chitty Bang Bang" at the London Palladium. We had a pleasurable trip by water taxi on the Thames to view Shakespeare's Globe Theater. This theater is an open-air playhouse which had been restored to its original color, design, and architecture of 1599 through the vision of noted American actor, Sam Wanamaker.

One of the highlights of our trip was the backstage tour of the Theatre Royal Drury Lane performed in character and costume by actors as ghosts. They led us down into the narrow underground passageways, through the backstage storage chambers, and into the area of the Royal Boxes.

Although theater was our emphasis, we also visited the Banqueting House Whitehall Palace, the National Art Gallery, featuring the Albrecht Durer Exhibit, Windsor Castle, Oxford, and Stratford-on-Avon. As we were strolling down the Mall, we even caught a glimpse of Queen Elizabeth as she whisked by in her royal limousine.

No trip is complete, regardless of its focus, without traveling to the local shops-in this case, Harrods. We went, we saw, but we left empty-handed. However, the shopping adventure was great!
