CHALLENGES OF MEMBERSHIP

Widening the Membership Box

As each chapter begins a new biennium and new chapter membership chairs take over the reins, think of ways to redefine your membership base. "If you always do what you always did, you'll always get what you always got" and so went the buzzwords from the concept of change agent of the 90's mentality. Some may remember when we were asked to consider alternative ways to accomplish and achieve educational endeavors using the "change agent" thinking.

As a new year for a chapter and, in most cases, a new chapter membership chair gets underway, it may be well to challenge ourselves with these "buzz" words. How can we build up our membership base and continue to experience a chapter of membership explosion? How do we achieve diversity, i.e., how can we get new members besides looking at colleagues teaching within our same districts, buildings, or grade levels? How do we find members once we're retired and have left the realms of easy access to Key Women Educators? The strength of our Society hasn't changed over the years. Guided by the seven purposes as a means to promoting professional and personal development of women educators and excellence in education, if anything, the box has been widened! An educational environment and those employed in it stretches well beyond the four walls of the classroom that limited the search used by our early leaders and members. Consider some of the following possibilities:

- □Look at schools or work places for regular and part-time teaching staff, specialists, substitutes, support personnel, and administrators
- ■Look at district, county, or state service centers such as mental health, migrant education, day care, or other social agencies
- Look at adult or community education courses
- Look at organized community park, recreation, sport, and leisure time programs
- □Look at senior citizen centers and those who provide the activities there
- Look at hospitals, nursing homes, assisted living, and care centers
- Look at libraries, museums, zoos, institutes, and service organizations
- □Look at health, wellness, personal growth, travel, enrichment, hobby, parenting, human growth and development speakers and events
- □Look at private teachers or tutors for instruments, drama, painting, etc.
- Look at those employed in technology and training
- Look at social and community events

The possibilities are endless.

Membership is everyone's business whether retired or actively teaching as we strive to "Lead with Wisdom and Passion." Our founder, Dr. Annie Webb Blanton, intended that the membership of each chapter should reflect the educational spectrum... and that spectrum has grown and extended well beyond the four walls that guided our search for Key Women Educators years ago. Allow the purposes to be the guide in your membership search.

Membership Explosion Update



Chapters are commended for stretching their efforts to bring in new members and in some cases meeting and achieving the challenge of Membership Explosion, the International Society's membership initiative for the 2006-2008 biennium. Congratulations to our overachievers. Alpha Xi is in first place for bringing in 17 new members and meeting the initiative of newer members having 3-10 years experience. Congratulations to Alpha Sigma for capturing second place and bringing in 15 new members and meeting the initiative of newer members having 3-10 years experience. And in third place was Alpha Rho who brought in 14 new members. Also to be commended are Beta Pi with12 new members, half of whom are newer members: Nu with 11 new members all of whom have 3-10 years experience; Alpha Theta with 11 new members, 4 of whom have 3-10 years experience; Beta Alpha with 10 new members, all of whom have 3-10 years experience; Alpha Lambda with 10 new members, 4 of whom have 3-10 years experience; and Tau and Beta Omicron, each bringing in 9 new members, 4 of whom are newer educators.

Twenty-two chapters or 34% achieved the initiative of membership explosion by bringing in 8 or more members during the 2006-2008 biennium and will be recognized at the convention in Chicago.

Last October, the state Membership Committee met and

What a wonderful birthday celebration we had at state convention in June! The state's two oldest chapters, Alpha and Beta, were able to celebrate their seventieth birthday. A total of ten chapters representing thirty to seventy years of existence were represented in the luncheon program. Those members had fun weaving their chapters' stories. One of the reasons why these chapters have been able to exist for so long, I believe, is because the members have made the effort and taken the time to get to know one another.

It is the responsibility of the Program of Work
Committee to provide opportunities for this to happen.
There is much diversity in our chapters so it is important to keep this in mind and plan accordingly. We need to value the differences between members and look at those differences as strengths. Have you heard of the ACORN Imperatives? They are five common approaches to make the differences become strengths:

Accommodate member differences. Leaders learn all they can about their members, working to meet their specific needs and serving them according to their unique preferences. Organization wide, there is a real effort to accommodate personal scheduling needs, work-life balance issues, and nontraditional lifestyles. Each generation's icons, language and precepts are acknowledged, and language is used that reflects all generations in the membership base.

Create chapter choices. Allow the chapter to shape itself around the people who belong. Listen to the members as they express their interests and needs.

Operate from a sophisticated management style. Be direct, but tactful. Identify the big picture and specific goals. Let members be creative; turn them loosethen give them feedback, rewards and recognition as appropriate.

Respect competence and initiative. Treat all members as if they have great things to offer and are motivated to do their best. Make every attempt to ensure a good match between people and the tasks they are asked to do.

Nourish retention. Generationally friendly organizations are concerned and focused on keeping all of their members. The leaders communicate with all, value differences, and accommodate as much as possible to meet their needs.

Our membership is comprised of women of different ages, at different stages of their lives, and from varied cultures. We can become better leaders by building bridges to those women, and that comes from changing our own behavior. A good leader must take time to

- Listen and help chapter members to listen when people have innovative ideas.
- Pay attention to suggestions. Ask members, "What would you prefer?"
- Probe for specifics. This process will often result in adjustments to a plan that will accommodate the input of others while making the overall change more workable. Not only will you have a better idea, you will have the motivation of the people involved.
- Consider criticism thoughtfully. Every improvement is the result of change, but not every change is an improvement. Give permission to let bad ideas die.

As we start off this biennium with new chapter officers, we know that one of the most daunting tasks for
the Program of Work Committee is to come up with
program ideas. Get to know your membership and
remember the lattice of leadership that President
Carolyn refers to so often; remember that the Alpha
Alpha State Program of Work Committee is always
available to help you anytime. At our workshop on
Saturday morning at state convention, the different
committee chairs shared many concrete ideas for use at
the chapter level. If you were unable to attend that, you
have another opportunity to receive training at one of
the Fall Area Conferences. (See page 18 of this isssue.)
I urge you to make the extra effort to attend.

Another valuable resource is the Program Resource Guide 2006-2010, "Passion for Learning-The Essence of Growth." If your chapter has not purchased this, it is available from International Headquarters. The CD only costs \$5.00; and the CD with printed version, \$20.00. Personal Growth and Services By Nikki McWilliams and Anita Pence

What a wonderful convention! What an incredible time the Personal Growth and Services Committee had weaving connections between our Delta Kappa Gamma lives, our personal lives, and our spiritual lives. It all started Saturday morning when our state committee spoke with our chapter counterparts about our responsibilities as Personal Growth and Services Committee chairmen. It ended with the Meditation and Reflection Service during which Donna Winch and committee member Shirley Newhart provided beautiful music guiding us in our meditations. Committee members Cathy Cortegerone, Anita Pence, Joan Peters, Carol Williams, Rini Wolfgarth, and Nikki McWilliams wove the threads uniting us in our reflections.

What can you do to "Energize Your Life?" That was the topic of the workshop presented by the committee Saturday afternoon. Emphasis was placed on the importance of paying attention to the significant things in your life and not stressing over the small stuff. Along with that, Joan Peters spoke about the importance of balance in our lives, remembering that each day is a gift. Joan reminded us that we need to be ourselves, not what others expect us to be. Anita Pence discussed

multitasking and how it is actually counteractive to true productivity and quality work. If we must multitask, we need to first learn one activity to the point that it becomes routine before we add a second task to do at the same time. Rini Wolfgarth explained the relationship between a healthy body and the energy we need to get through a day. Eating a proper diet balanced between fruits and vegetables (1/2 of your plate), protein (1/4 of the plate), and carbohydrates (1/4 of your plate) is of prime importance. We relieved our stress as Rini led us through several simple exercises which we can do almost anywhere. Nikki McWilliams stressed the importance of getting at least 7 - 8 hours of sleep a night along with providing tips to help us sleep. Finding laughter in our lives and sharing friendships have been proven to relieve stress and help us cope with our daily lives, especially for women.

It absolutely was a wonderful convention! For the Personal Growth and Services Committee, it was fun to share ourselves with others, but most of all a privilege to be part of the tapestry woven by President Carolyn Sutton.

Apropos the project of "Membership Explosion," 23 chapters, or 37% of Alpha Alpha State, will be recognized at the 2008 International Convention in Chicago. A total of 47 chapters, or 73%, reached the goal of membership set by the State in the last biennium.

The current state project, "Ethiopia Reads," is intended to improve literacy and levels of culture and reading by establishing libraries and supplying books, a most worthwhile endeavor at this time in history.

The International Guest, Drs. Trijny Schmitz du
Moulin of the Netherlands, who is the Director of the
European Region of the Society, spoke about the following: proposed International dues increase, the need to
recruit members, expansion (The latest European country is Estonia.), supporting and mentoring new teachers,
the global exchange on the web site, the updating of the
history of the Society, International Research Study, nurturing artists, scholarships, and an online leadership
course.

Workshops focusing on Society business preceded the Birthday Luncheon. With Susan Stamm presiding, enjoyable songs and skits were offered by most of the 16 chapters being honored in special birthday tributes.

During the afternoon a series of workshops for enrichment gave attendees a good variety of topics from which to select both interesting and informative sessions for personal growth, literary and musical connections, and educational foci. A favorite activity was the visit to the Paterno Library, where the Alpha Alpha State Historical Records now enjoy a permanent home.

The Presidents' Banquet on Saturday evening, with Louann Shrader presiding, was a most elaborate and enjoyable "golden thread" of the weekend tapestry.

Musical interludes, featuring flute and piano selections and the Alpha Alpha State Chorus, were outstanding. Again, Drs. Trijny Schmitz du Moulin spoke and gave us prodigious concepts about "How to Live Your Life." She said, "Life is a process, and so are we. Everything that happens in our life is an integral part of our being. The most important part of life is the life experiences we have had with no worries about tomorrow, no regrets about our past, and making a meaningful present by doing significant things, not just thinking about them. Our lives are very precious, with the great potential for new discovery. Leave the future open! ENJOY!"



Women Vote PA - "A Women's Law Project Initiative"

The Pennsylvania Commission for Women serves as a strong advocate for women's rights and works to ensure that women and girls have equal opportunity and treatment in all aspects of life. This initiative asks women. What Can You Do?

First Step: Register to Vote

Registering to vote and voting are extremely important, especially if you want to have an impact on particular issues. Elected officials at all levels of government respond to constituents, mainly because constituents have the power to elect them to office; therefore, being registered to vote and being an informed constituent will help in moving your issues forward.

Second Step: What is your issue?

What issue or issues do you care about? Whether it's job security, equal pay, child care, public education, ending violence, electing more women to public office, or reducing mercury emissions from power plants - whatever the issue, they all need advocates.

Third Step: Learn more about your issue

Find out which groups or advocacy organizations support your issue. These organizations may have helpful information that you can use for talking points when educating others, including legislators, about your issue.

Fourth Step: Involve friends, family and neighbors It's important to work locally, and to engage your friends, family and neighbors in discussions about your issue. Consider hosting a meeting in your house, local community center or room at the public library. WomenVote PA will help you with materials to lead discussions.

Fifth Step: Lobby Your Elected Official WomenVote PA will also work with you and your group to learn how to lobby elected officials

Sixth Step: Consider Running for Elected Office

Once you become proficient at steps 1 through 5, you may want to run for office. Of course not everyone will want to take that step, but we do need more women to run for public office and ensure that women's voices are present helping to shape public policy and priorities.

Federal Health Coverage Programs: An Issue for the 2008 Presidential Campaign

According to Rowland and Shartze in their article Federal Health Coverage Programs: Building Block for Coverage of the Uninsured (2008), as the 2008 presidential campaign gears up, health care reform is ranked just below Iraq as public priority. Thus, it has become a top issue for candidates to address. Filling the gaps in coverage that leave millions uninsured, constraining rising health care costs, and improving the quality of care are the goals of reform efforts.

The health care system in the United States is under a lot of pressure. In 2006, 47 million Americans lacked health insurance coverage. Health care costs continue to rise faster than inflation and wages, with premiums increasing 78% since 2001. Roughly half (54%) of all Americans get their health coverage through their employers, and a smaller share purchase coverage directly. Together Medicare and Medicaid provide publically-sponsored coverage to one in four Americans who are elderly, disabled or low-income (income less than twice the poverty level, roughly \$40,000 for a family of four). Building on this coverage to assist the 16% of Americans who are uninsured is a key component of reform.

IT'S AS CLEAR AS GLASS...THIS WAS AN ENRICHING EXPERIENCE!

As a recipient of the Enrichment Grant in 2007, I would like to give a report about the wonderful experience I had in taking 2 classes at Touchstone Center for crafts.

Last year in Pittsburgh, there was a national conference held by the Glass Art Society. This conference was the impetus for "The Year of Glass" in Pittsburgh.

Almost every gallery and museum in and around the city featured exhibitions and workshops about glass. I was able to attend the GAS conference and several of the museum exhibits including the Dale Chilhouly show at Phipps Conservatory. This was the kick-off for my own "Summer of Glass."

The next week after the conference was my first class at Touchstone with Kate Fowle Meleney from Rhode Island. Kate is a nationally and internationally known beadmaker who is instrumental in the current art glassbeadmaking movement. During that week, I learned many new techniques I had never been able to experience before such as electroforming with copper on glass and fuming gold and silver metals on glass. Also we were exposed to several new types of glass from companies such as Kugler and Reichenbach from Germany, Kate is a

phenomenal teacher and was willing to spend time individually with every student. The other students in the class also had a lot of skills to share as well. since many of them are also accomplished bead makers. This class is usually full at Touchstone, so I was honored to even be able to get in. What a

week!

Two weeks after Kate's class was my second class at Touchstone. This class was taught by Deanna Griffin Dove from Virginia. Deanna is also a nationally known beadmaker and top quality teacher. She also publishes books about beadmaking techniques. In this class, there were only three students, so we had incredible individual instruction. The focus for the class was encasing techniques in which many layers of colors and designs are built up on the mandrel and then covered with a clear/transparent layer of glass which then magnifies the designs inside. We spent a lot of time working with murrini canes in which designs are created on the rod of glass and pulled out to decorate other beads with a multitude of mixed colors and patterns.

My landscape bead was my biggest accomplishment of the week. We used photos from nature from books and tried to interpret the photo - colors, composition, etc., in a bead. The larger type beads such as these take approximately 2-3 hours to make!

> Again, the week was exhausting, but so rewarding. Both weeks at Touchstone consisted of

class work from 9:00 a.m.- 4:00 p.m. In the evenings, there are demonstrations in all the other studios so I also was able to learn about blacksmithing and working with metal, ceramics, precious metal clay, feltmaking, and silk-painting/shibori techniques. After the demos, it was back to the studio to work until 11:00 p.m. or so!

After my two weeks at Touchstone, I have a whole new set of friends I still keep in touch with and can continue my education by contacting my instructors if I have any questions.

Even though my enrichment grant funded my time at Touchstone, I continued my professional development the next week after my class with Deanna Griffin Dove by attending the Governor's Institute for the Arts at Valley Forge, PA. During this week, we were immersed in the Arts of Japan and wrote curricular

materials for educators that have content in the visual arts, music, theater, and dance, but cross over to incorporate standards and assessment anchors in reading and math.

There was also a technology component to the course in which the focus was creating podcasts to be broadcast on Ipods through the internet. The work is accessible to all teachers who wish to use it by going to www.keyarts.ws. This site will show the results of the Japanese units and have the podcasts available for viewing and listening,

In conclusion, whew, what a summer! I am so thankful to Delta Kappa Gamma for allowing me to grow as an artist and educator.


